## **Re: CSBA and City Equity Agreement**

Dear Mr. Fishman:

This is to confirm the understanding and agreement of the parties use of the 0.88% Equity Fund consistent with the terms of the 2021-2026 Civil Service Bar Association ("CSBA") Memorandum of Agreement ("MOA") between the City of New York and the CSBA.

Effective October 18, 2023, the existing April 18, 2023, "After 1" year of service increment for the Recurring Increment Payment ("RIP") shall increase by the amount of \$437 and the "After 5" years of service increment shall increase by the amount of \$668 as set forth below:
