Thanking the Sisterhood

arch is Women's History Month and across the nation, there will be special events and tributes to mark the accomplishments of women in America.

In seminars, conferences, TV specials and marathon runs, the accomplishments of women historically and today will be on full display. March is a time when the struggles, wisdom and unique perspective of women are recognized, analyzed and immortalized from the words of Maya Angelou, who once wrote: "Each time a woman stands up for herself, without knowing it possibly, without claiming it, she stands up for all women." To Rihanna, "There's something special about a woman who dominates in a man's world. It takes a certain grace, strength, intelligence, fearlessness, and the nerve to never take no for an answer." There are so many extraordinary women, past and present, who personify these sentiments from the unsung heroines, like a next-door neighbor who juggles two jobs and three kids to make a house a home, to the unparalleled bravery of Harriet Tubman to Rosy the Riveter, who inspired a generation, to current women of valor—like the young soldier who left her family behind and stands guard in the Middle East, to women who took a sledgehammer to the "glass ceiling" like Vice President Kamala Harris, Supreme Court Justice Ketanji Brown-Jackson and New York State Attorney General Letitia James, to women who express such tremendous empathy and compassion for people they have never met, like the neonatal nurse tenderly caring for preemies, to Dr. Ruth Gottesman, who just made a historic donation of \$1 billion to the Albert Einstein College of Medicine in the Bronx to provide medical students with free tuition going forward.

In the labor movement, there are many women who have set examples of courage and determination to improve the lives of working women and families. Some did so indirectly and regrettably as in the case of the 146 young immigrant garment working girls killed, and the 78 who sustained injuries, in the notorious Triangle Shirt Waist Factory fire in Greenwich Village on March 25 of 1911. From exit doors chain-locked by their employers to Fire Department ladders too short to reach them on the 8th floor, the findings in the aftermath of that horrendous fire led to our state and the nation to legislate safety and health hazard measures to protect workers on the job. Women have in fact come a long way and played a significant part in building labor unions since those young sweat shop girls perished in a fire largely because they didn't have a union. Today, Elizabeth H. Shuler is president of the national AFL-CIO, a federation of 57 unions and 12.5 million working people across all sectors of the US economy. She is the first woman to hold that position.

At Local 237, we don't have to look very far for fearless women with an extraordinary strength of character who exemplify "never take no for an answer". They are the sisterhood, working with the International Brotherhood of Teamsters. One such Local 237 member is Marie Colvin. Marie was a war correspondent. She wrote about innocent women and children caught in the crossfire of civil war. Her bravery was legendary. A movie, "A Private War", tells the real-life story of Marie Colvin, portrayed by Rosamund Pike. It depicts her life behind enemy lines covering stories of human suffering that many did not want told, in dangerous locations, where few would dare to go. It was actually a sentence in one of the movie's reviews that caused us to wonder about a possible link to Teamsters Local 237. Our research paid off because we discovered that fresh out of college, she was hired by Local 237 to write our newsletter. Marie Colvin was a Teamster! Her family told us that she wore our lapel pin proudly. One could

easily imagine her today, condemning the bombing of innocent women and children in Ukraine, Israel, and Gaza — if she were still alive. Marie's jour-

Gaza — if she were still alive. Marie's journalistic diligence caused her to lose her eye at the hands of Sri Lankan terrorists in 2001, then her life, at age 56 in 2012,

killed by a senior Syrian military officer to silence her. As proud as we are of Marie, there are several other Teamster women who have done remarkable things on different battle grounds. For example: In March of 2010, Local 237 sued New York City on behalf of our 5,000 School Safety Agents, 70% of whom were women, mostly African Americans and Latinas. Many were single mothers. Their annual salary was about \$7,000 less than their counterparts with similar titles working in other City agencies, who are mostly male. Some called this just a coincidence. It was discrimination! School Safety Agents have a tough job to do. They help to protect other peoples' children. All they wanted was to put bread on the table for their own children. So I called for a meeting of School Safety Agents to tell them about plans to sue the City. I told them that we needed some volunteers to sign the papers and be the official plaintiffs. Of the 25 women in the room, 22 left. But three remained: Patricia Williams, Bernice Christopher and the late Corinthians Andrews. And for four years, these three gave testimony after testimony. They refused any settlement that did not include retirees. They took days off from work. They took time away from being with their families. They worked on the case despite health issues and attended our rallies. At times, we felt pretty much alone, but then we received support from several luminaries, including: Dr. Hazel Dukes, President of the NYS NAACP; Sonia Ossorio, President of the NYC Chapter of NOW; and Lilly Ledbetter, who learned first-hand about gender-based pay discrimination when an anonymous note left in her locker on her last day at work before her retirement let her know that she was earning much less than her male co-workers, and she took her fight all the way to the Supreme Court. Lilly Ledbetter came from her home in Alabama to stand in solidarity with Local 237 on the steps of City Hall for our protest rally.

Finally, after years of rallies and legal wrangling by the City, judgment day came. I still remember Pat, Bernice, and Corinthians walked into the courthouse and knelt in prayer before they took their seats. Perhaps there was a little divine intervention, but with the help of Hazel, Sonia and Lilly an historic settlement was reached. Clearly, the words of Vice President Kamala Harris ring true: "You're going to walk into many rooms where you may be the only one who looks like you or has had your experiences. So, use that voice and be strong." And that's exactly what these women did!

Throughout the pandemic and hard economic times, our women members have played and continue to play an integral part helping to keep the City functioning. Women's History Month is the time organizations single out extraordinary women to honor. For us, at Local 237, it is not a difficult task. We are especially blessed to have among our own members so many who have distinguished themselves through acts of integrity and humanity. So, while we thank the historic, heroic women who made headlines, we take pride in acknowledging our own Pat, Bernice, Corinthians, and Marie and the sisterhood of Teamsters Local 237. I

"ALL THE NEWS THAT'S FIT TO PRINT"

That is the slogan of the New York Times, which recently applied the sentiment to an article about the NYPD's Evidence and Property Office by **Chelsia Rose Marcius**, which featured Local 237 member, Eugenio Ramos, an Evidence Specialist and Grievance Representative. Below is an excerpt from that article, entitled:

A Plush Dog, Samurai Sword and 42,439 Guns: Inside an N.Y.P.D. Basement

The NYPD office of the Manhattan Property Clerk is a subterranean repository for lost objects and the tangible aftermath of crime and misadventure. Almost every item that passes through the borough's 22 precincts must go to the basement to be numbered and cataloged to be held as evidence for a trial or wait for its rightful owner. Some objects come from crime scenes. Others were turned in after they were left behind on a park bench or a sidewalk. To make room, workers routinely take inventory to see which items meet the stringent criteria for removal. Two white sheets of paper pinned to a bulletin board offer a reminder: Lost objects worth at least \$5,000 have to stay for three years. So do guns used in felonies. And any evidence related to a homicide, sexual offense, arson, explosion or an internal affairs investigation has a simple note: "Never destroy." But

the inventory is always growing. During business hours, five days a week from 8 a.m. to 2:30 p.m., a procession of officers passes through doors that resemble those of the Death Star. The clerk's office has a rolling schedule for precincts to help handle the inexorable accumulation of stuff. The officers bear clear, sealed plastic bags filled with what was left behind when laws were broken. On this day, Sergeant Consuegra watched as Eugenio Ramos, an evidence specialist, examined a black toy gun. He then looked through the corresponding paperwork to check for errors. Whenever he finds a mistake, Mr. Ramos must send the evidence or property back to the precinct it came from, and the process begins again. Items that clear inspection are assigned a number that determines where

they will be stored. The most sensitive — guns, drugs and money — are kept in the two rooms of the basement vault. "This is quality control," Sergeant Consuegra said, adding, "You cannot break that chain of custody."



Governor Hochul Announces Tentative Labor Agreement Covering Over 10,000 CUNY Employees Including Teamsters Local 237



Governor Kathy Hochul announced on Wednesday, January 10 a tentative labor agreement lasting over five years between The City University of New York and Teamsters Local 237, District Council 37 and SEIU Local 300, covering over 10,000 employees, including custodial staff, college assistants, IT and public safety officers. The proposed retroactive contract is subject to approval by the CUNY Board of Trustees and ratification by the union membership.

Teamsters Local 237 President Gregory Floyd said: "This was a difficult negotiation, but with the collective efforts of Governor Hochul, Mayor Adams and CUNY Chancellor Matos Rodríguez, we have reached an agreement to bring to our members."

In a statement by Governor Hochul she said: "This tentative agreement will help to ensure that these hard-working employees of The City University of New York are fairly compensated for the work they do every day to support New York's college students." My administration is committed to standing up for workers and ensuring they get the wages and benefits they deserve."

Maintenance Contract Ratified

The contract was overwhelmingly approved by Local 237 maintenance members working at NYCHA, City agencies and CUNY. The ratified contract includes annual raises totaling 16.21%, retro-pay and a \$3,000 signing bonus, as well as the protection of healthcare and supplemental union benefits at no additional costs to workers. Maintenance workers also won a new benefit — Comp. time or cash for overtime hours. $\ ^{\parallel}$

Hot City Issues Come to a Boil This Spring

Canceled Budget Cuts Headline Spring's Political News

Many New Yorkers breathed a sigh of relief when Mayor Eric Adams announced late in February that promised budget cuts were no longer in the offering. This is of particular relief to our members and their families since New York City agencies were staring down the barrel of a 5 percent cut in spending for April 2024 on the heels of two previous rounds of budget cuts. Further comfort could be found in Mayor Adams' announcement that there would be a relaxation of the hiring freeze that was in place, along with other limits on contract spending.

Higher than expected revenue projections, along with a 10 percent drop in the cost of sheltering migrants were the primary reasons for the good budget news.

The relaxation of the hiring freeze will allow city agencies to hire a new person for every two individuals that leave. Also, among the rollbacks are cuts in all non-salary spending for everything from supplies and equipment to contract services. *February Special Elections*

Former Democratic Congressman Tom Suozzi was victorious in a special election for Long Island's 3rd District to replace former GOP Congressman, George Santos. Suozzi defeated Republican Mazi Pilip despite the snowstorm that battered New York City on election day. There is a very good chance Suozzi and Pilip will face off again in the general election in November.

Also, victorious on the snow-covered day was attorney Landon Dais who prevailed in the Assembly race for the 77th District seat in the Bronx, representing portions of Claremont, Concourse, Highbridge, Mount Eden and Morris Heights. Dais succeeds Democrat Latoya Joyner who resigned the seat in January.

Looking ahead, Republicans chose former NYPD Detective Mike Sapraicone at their convention as their nominee to run against Senator Kirsten Gillibrand in November. Though Sapraicone won over a majority of Republican delegates at their Binghamton convention, he still faces a primary challenge from two conservative members of the party, Josh Eisen and Cara Castronuova.

NYCHA Gets New Federal Monitor

The international law firm Jenner & Block will serve as NYCHA's new independent monitor beginning on March 1st. Jenner & Block succeed Bart Schwartz and his consulting company, Guidepost Solutions, which have served as the monitor since February 2019 in an agreement between NYCHA, then Mayor Bill de Blasio, and the U.S. Department of Housing & Urban Development (HUD). The independent monitor is meant to help NYCHA address issues of neglect and mismanagement as it concerns its properties and tenants.

Though they applied to continue their work, Schwartz and Guidepost failed to meet many of the milestones set out to improve living conditions in NYCHA's properties. For this reason, HUD, the Manhattan U.S. Attorney and the City decided to move on to Jenner & Block. Two partners from Jenner & Block will offer their monitorship for free but will charge the city for its services and any consultants they decide to hire.

NYCHA Residents Set for Second "Trust" Vote

In mid-March almost 200 seniors at NYCHA's Bronx River Addition in Soundview will follow their neighbors at the Nostrand Housing in Brooklyn and vote on whether the Housing Authority should bring in private developers, maintain traditional public housing, or count on the Public Housing Preservation Trust to perform upgrades and repairs.

In December 2023, the Nostrand tenants voted overwhelmingly for the Trust option – over 750 votes.

Since as a public authority NYCHA cannot issue bonds, the Public Housing Preservation Trust was set up as a non-profit in association with NYCHA, that will have the ability to raise billions of dollars for repairs through the bond market. The Trust is overseen by a 9-member Board of Directors – one of those directors is a labor representative, who is a Local 237 member.

Though the Brooklyn vote was a blow out for the Trust and a strong vote of confidence in NYCHA's public employees, the Bronx River vote is complicated by the fact that many of its households are scattered throughout the city. Due to a faulty heating system, Building 12 in Soundview was deemed uninhabitable and 60 seniors were forced to move to temporary residencies throughout the city.

Even though tenants can mail-in ballots or vote remotely, the fact that so many residents are spread across the city has complicated outreach and voting educational efforts.

Remote voters can cast ballots by mail or online for 30 days beginning March 13th, which is followed by 10 days of in-person voting between April 2nd and April 11th. The voting near the Bronx River Addition will take place between 10:00 am and 7:00 pm on all days. Developments opting for the Trust will continue to be managed and maintained by Local 237 members.



Not a Time to Wait: "Spring" Into Action!

An excellent opportunity is right down the street at your corner bank or credit union. Interest rates on savings accounts are significant again! And if you didn't take advantage of this opportunity last year, you are not too late!

What created the opportunity? The Federal Reserve Bank's action over the last two years to dramatically raise an underlying interest rate it controls. Such action is taken to combat significant inflation: although it is painful for borrowers, it creates the opportunity savers enjoy today.

High-yield savings account rates are close to 5%, almost twice the last-40-year average rate on Cash. For savers willing to "lock up" funds for short periods, measured in months, Certificates of Deposit ("CDs") should offer a bit more. (If you are comfortable with online banking, rates can be even better, without sacrificing important FDIC insurance.) Finally, one can get the best of two worlds – handsome rates and flexibility – by "laddering" CDs of different lengths (for example, putting a little money into each of a three-month, six-month, and nine-month CD). Consider discussing this with your institution – or, if you are unsure how all this works, call Stacey Braun for an appointment first!

Help Us Spot Government Imposters

Do you know how to spot a government imposter scam? We continue to raise public awareness about Social Security-related and other government imposter scams during the fifth annual "Slam the Scam" Day on March 7, 2024. Knowing how to identify potential scammers will help safeguard your personal information.

There are common elements to many scams. Scammers often take advantage of fears and threaten you with



arrest or legal action. Scammers also pretend to be Social Security or other government employees and claim there's a problem with your Social Security number (SSN) or your benefits. They may even claim your SSN is linked to a crime.

When you suspect you've been contacted by a scammer:

- Hang up right away or ignore the message.
- Never provide personal information, money, or gift cards.
- Report the scam immediately to our Office of the Inspector General (OIG) at oig.ssa.gov/scam-awareness/report-the-scam.

If you owe money to Social Security, we'll mail you a letter with payment options and appeal information. We only accept payments electronically through <u>Pay.gov</u>, Online Bill Pay, or by check or money order.

We will never:

- Threaten you with arrest or legal action because you don't agree to pay us money immediately.
- Promise a benefit increase in exchange for money.
- Ask you to send us gift cards, prepaid debit cards, wire transfers, internet currency, cryptocurrency, or cash through the U.S. mail.

Scammers continue to evolve and find new ways to steal your money and personal information. Please stay vigilant and help raise awareness about Social Security-related and other government imposter scams. For more information, please visit www.ssa.gov/scam.

Tell your friends and family about government imposter scams. Let them know they don't have to be embarrassed to report if they shared personal financial information or suffered a financial loss. The important thing is to report the scam right away.

Together, we can "Slam the Scam!"

El Mensaje de la Primavera



¡Ah, primavera! Día de la Madre, Día Conmemorativo, los capullos se convierten en flores; el primer lanzamiento de béisbol de la temporada ha sido hecho entre los aplausos de los aficionados esperanzados, olvidando un decepcionante último año; los camiones del Sr. Softee están de vuelta en la carretera volviéndonos locos con esa molesta melodía, una llamada a los niños ansiosos por esperar en la fila para el primer sorbo de helado; y es tiempo de reservar tus vacaciones de verano... preguntándote, "¿entraré en mi traje de baño?"

¡Ah, primavera!

Mucho se ha escrito y dicho sobre la primavera y sus atractivos. El gran jugador de béisbol Ernie Banks dijo: "El entrenamiento de primavera significa flores, personas saliendo al aire libre, sol, optimismo y béisbol. El entrenamiento de primavera es un momento para pensar en ser joven de nuevo." La ex Primera Dama, Ladybird Johnson, dijo: "Donde florecen las flores, también lo hace la esperanza." La cantante y compositora Sheryl Crow escribió de manera memorable sobre la primavera: " No importa cuán caótica sea, las flores silvestres seguirán brotando en medio de la nada." Y la Madre Naturaleza parece estar de acuerdo con estos sentimientos, ya que la luz del día dura un poco más y nuestras botas para la nieve quedan relegadas al fondo del armario. Parece que finalmente podemos empezar a dejar el caos del COVID en el espejo retrovisor; hay una sensación de que la primavera definitivamente ha surgido, trayendo nuevos comienzos, un nuevo comienzo, una pizarra limpia, y la inspiración también.

Se ha escrito mucho sobre la temporada. Toni Morrison, la renombrada escritora y ganadora del Premio Nobel de Literatura en 1993, una vez escribió: "Cuando llega la primavera a la ciudad, la gente se fija en los demás en el camino; se fija en los extraños con quienes comparten pasillos y mesas y el espacio... Es la época del año en que la ciudad insta más a la contradicción animándote a comprar comida callejera cuando no tienes apetito en lo absoluto; dándote un gusto por una habitación ocupada solo por ti, así como un deseo de compartirla con alguien con quien te cruzaste

en la calle. Realmente no hay contradicción, más bien es una condición." La fundadora ghanesa de la Smart Youth Volunteer Foundation, Lailah Gifty Akita, llama a la primavera: "Una temporada para que el alma recupere su fuerza." E incluso, el comediante Robin Williams tenía una opinión sobre la primavera, llamándola "La forma en que la naturaleza dice '¡Vamos de Fiesta!".

No es casualidad que el Ramadán, la Pascua y la Pascua Judía sean festividades de primavera. La renovación de la naturaleza que llega con la primavera amplifica la promesa de redención incrustada en los acontecimientos históricos, que son conmemorados por las tres religiones. El Ramadán, una celebración que dura un mes, marca el mes más sagrado del calendario islámico. Según la tradición, el Libro Sagrado del Corán fue revelado al profeta Mahoma durante el Ramadán. Los musulmanes creen que, durante este mes, las puertas del Cielo están abiertas y las puertas del Infierno están cerradas. Los musulmanes se centran en su conexión con Dios, reflexionan sobre sus vidas y pasan tiempo de calidad con amigos y familiares. La Pascua celebra la resurrección de Jesús y su victoria sobre la muerte. Casi al mismo tiempo, y a menudo superpuestas, los judíos celebran la Pascua, la festividad que conmemora el éxodo de los hebreos de la esclavitud en Egipto. En ambas festividades, la naturaleza y la historia convergen con un mensaje resonante de esperanza. Estas festividades se tratan de la liberación de un estado de desesperación. La Pascua asegura al in-<mark>dividuo que la vida es eterna. Ofrece una salida</mark> de un mundo irreparable. Celebra una religión que brinda consuelo a aquellos que habían perdido la fe en los dioses de Roma. Difunde el mensaje de que la muerte de uno tiene la capacidad de salvar a muchos, y la resurrección de Jesús es la afirmación última de la vida. La Pascua Judía convoca colectivamente a los judíos al mundo para repararlo/redimirlo. El mensaje de la Pascua Judía indica que un faraón tirano podría ser derrocado. Una nación tan poderosa como Egipto podría ser derrotada. Los esclavos podrían convertirse en hombres libres. Los oprimidos podrían romper

las cadenas de su cautiverio. Todo es posible si tan solo nos atreviéramos a soñar el sueño imposible.

Fue el relato bíblico del Éxodo de Egipto lo que permitió que el espíritu de optimismo prevaleciera en la búsqueda de la igualdad de derechos, porque fueron conmovidos por la visión de Moisés guiando a su pueblo hacia la Tierra Prometida. De hecho, el histórico discurso que King pronunció en el Templo Masón de Memphis, donde él fue el 3 de abril de 1968 para apoyar a los trabajadores de saneamiento que protestaban por sus magros salarios de 1,65 dólares la hora y sus deplorables condiciones laborales, incluyó la frase profética: "Quizás no llegue allí con ustedes. Pero quiero que sepan esta noche que nosotros, como pueblo, llegaremos a la Tierra Prometida." Fue asesinado al día siguiente. Era irónico que muchos de los partidarios, ayudantes y confidentes de King le habían instado a no ampliar su enfoque y abandonar su zona de confort para asumir nuevas causas, como la Campaña de los Pobres, que él estaba impulsando. King no aceptó nada de eso. En cambio, instó a los trabajadores de saneamiento a ir a la huelga diciéndoles: "Tienen que intensificar un poco la lucha." Y contrarrestó el argumento de la contención con: "Hemos entrado en una era en la que estamos llamados a plantear ciertas preguntas básicas sobre toda la sociedad."

Cuando celebramos el legado del Dr. Martin Luther King Jr., es imposible no reconocer que sus lecciones son similares a la lección principal de la primavera: Sin esperanza, todo se perderá. Tanto en nuestra nación subraya ese sentimiento. Incluso el dibujo en el sello oficial de Estados Unidos, sugerido por Benjamín Franklin en agosto de 1776, atestiguó esta creencia, con la dramática escena descrita en el Éxodo donde Moisés divide las aguas del Mar Rojo que está representada en el sello. La historia de nuestra nación, la esperanza y el sentido de renacimiento que inspira la primavera, tienen un mensaje claro: Lo imposible puede suceder, solo lleva más tiempo. El Dr. King creía en eso y lo vivió. Nosotros también deberíamos hacerlo.
