NOTE:

\* Full-time per annum and full-time per diem employees in the above titles shall be eligible to receive the Recurring Increment Payments.

For the purposes of determining eligibility for the RIP, only service in any of the titles listed in Article 1, Section 1 of the 2008-2010 Unit Agreement shall be deemed eligible service.

The RIP's shall be based upon years of eligible service and shall be paid in addition to the Longevity Differential set forth in Section 9 and the Longevity Increment set forth in Section 10. RIP's shall be payable January 1, April 1, July 1, or October 1 subsequent to the qualifying employee's anniversary date, subject to the rules for eligibility set forth in Appendix B of 2008-10 Unit Agreement.

\*\* Agency Attorney (title code 3008G) will be equalized to Agency Attorney (title code 30087) and Attorney at Law (title code 30085) effective April 18, 2023.
